Online Applications are invited from residents of UT of J&K and Ladakh who are eligible and desirous of appearing in the Entrance Test for admission to **Three Year Diploma Polytechnic** for academic session 2020. The selection of the candidates shall be governed by the J&K Board of Professional Entrance Examination Act, 2002 and the Rules and Regulations there under; JK Reservation Act, 2004 and the Rules there under and guidelines as contained in the **Electronic Information Brochure-2020**. 10. *The examination may be conducted online/offline as may be decided by the Board.*





### **Online Application forms:**

The Application Forms have to be **submitted online only** through the BOPEE websites [www.jkbopee.gov.in](http://www.jkbopee.gov.in) / [www.jakbopee.org](http://www.jakbopee.org) (through URLs/ links provided for this purpose) from **23<sup>rd</sup> March to 12<sup>th</sup> April, 2020**. The payment of Rupees 500/= (Rupees five hundred only) as fee is to be made also online through integrated Bill Desk Payment Gateway which can be used to make payment with any national Credit Card/Debit Card/Net Banking. The procedure for filing Application Form and eligibility etc. of the candidates has been given in detail in the e-Brochure. The applicants must necessarily, in their own interest, go through this e-Brochure before attempting to fill up the online Application Form.

The applicants are advised to fill the online Application Forms on their own or through a responsible person. The applicants can avail services at Common Service Centres of J&K for filling up online Application Forms at nominal charges. They can also avail the services at any National Informatics Centre located at the office of the Deputy Commissioner of the concerned District or BOPEE offices Srinagar/ Jammu.

### **Submission of Online Application Forms:**

The interested candidates have to upload the following scanned original / self- attested certificates in PDF format with size from 100-200 KB along with the Application Form:-

- (i) Valid Residence Proof Certificate of candidate belonging to UT of J&K or Ladakh, as the case may be;
- (ii) Qualifying marks certificate; ( where result is declared)
- (iii) Date of Birth Certificate; and
- (iv) Reserved category certificate, if any, (including Sports Certificate/TFW certificate) on the prescribed Proforma. (Duly renewed where ever applicable)

### **Note:-**

1. The candidates can change/ modify their online Application Form at any time before it is submitted online. However, for any subsequent modifications, if required, the candidates should approach the BOPEE office Srinagar/Jammu. They are advised, in their own interest, not to share their login details with any other person, lest he/she may get an opportunity to change important details in the Application Form. They can check the status of their Application Form on the official website(s) of the BOPEE. If any form is not confirmed for want of required information, the candidate concerned must report in the BOPEE office Srinagar or Jammu by or before **15<sup>th</sup> April, 2020** failing which his/her Application Form shall be rejected.
2. Candidates shall also have to upload their photograph, signature and thumb impression images in JPEG format and size within the range of 10-50 KB as given in the instructions in the e-Information Brochure and on the BOPEE website(s).
3. The candidates must, after filling up all the required entries, ensure that their online payment has been successfully made and all the requisite documents have been uploaded in specified format/size. Mere downloading of the Application Form does not mean that the candidate has submitted his / her Application Form successfully. Candidate should ensure that he/she keeps



checking the status of his/her online application forms until it is scrutinized by the Board and approved/accepted.

4. For any help/assistance candidates may call “**Help Desk**” numbers during office hours of the working days.

### **Eligibility**

1. The Applicant must:
  - a) be a resident of J&K or Ladakh, as the case may be;
  - b) have passed 10<sup>th</sup> Class Examination from a recognized Board/Institution;
  - c) have obtained not less than **40%** of marks in aggregate in the qualifying examination in case of open merit candidates, not less than **37%** of marks in aggregate in case of reserved category candidates.
2. The candidates appearing/ appeared in the qualifying examination are also eligible to appear in the Entrance Test but they have to upload/submit the qualifying examination certificate within the prescribed date to be notified separately.

### **Instructions:**

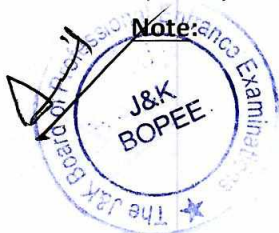
1. No under process certificates will be accepted;
2. The information provided by the candidates in the online Application Form cannot be verified from the original documents by the BOPEE officials before admission of the candidates. The information on the Application Form downloaded Page or on the Admit Card of candidate shall in no case be construed as an acceptance of such information/category certificate by the BOPEE. Therefore, if at any stage, it is found that a candidate has provided false or incorrect information in respect of any eligibility condition, his/her candidature will be cancelled without any further notice;

### **Warning:**

The Candidates are warned not to resort to any unfair/fraudulent means or act of impersonation at the time of Entrance Test or upload any objectionable material including a photo of any object, other than his/her own photograph while submitting the online form. In case, a candidate is found taking recourse to such acts, criminal prosecution shall be launched against him/her and his/her abettors. He /she shall be permanently debarred from appearing in the Entrance Test in future.

### **Original Documents Required to be submitted in the Institution at the time of Admission:**

- a) Marks certificate of the qualifying examination;
- b) Date of Birth (Matriculation Certificate/Secondary School Certificate) from the Board of School Education;
- c) Valid Resident Certificate as mentioned above; and
- d) Category Certificate, if any.
- e) Any other document as may be required by the Institution.





- I. **The sports category candidates have to indicate their sports category on the Application Form and upload valid sports certificate(s) issued by the Competent Authority. They are also required to submit their Sports certificate(s) in the office of the Secretary Sports Council for determining their sports points which will afterwards be officially forwarded by the Council to the BOPEE. The BOPEE, however, shall not be responsible for non-inclusion of any candidate in the list forwarded by the Sports Council or for their delay in submission of sports points to the BOPEE.**
- II. **The candidates having more than one reserved category certificate can get benefit of only one category indicated and uploaded along with the Application Form which in no case shall be changed afterwards. The candidate, whose category certificate has not been found valid, will be considered in open merit, if otherwise found eligible, without any further notice.**

**Roll No Slip/Admit Card:**

The notification for downloading of online/electronic admits card will be issued separately. The candidates, who fail to download their admit card, must report in the office of the BOPEE Srinagar/Jammu immediately. The electronic admit card will indicate time, Venue and schedule of the Entrance Test. The electronic Admit Card shall have the space for photograph of the candidate. The candidate has to affix his/her photograph which should then be attested by Gazetted officer. A candidate will in no case be allowed to appear in the Entrance Test without attested photograph on the Admit Card. The candidates are advised to remain in touch with the official Website(s) of BOPEE for updates for Centre notification and for other important information relating to Three Year Diploma Polytechnic Entrance Test (PET) - 2020. The candidates will receive SMS and/or e-mails for updates at various stage during the entire process of filling up of the online application form till selection of candidate, if applicable.

**Issuance of Admit Cards and Date of Test:**

Information with regard to availability of Online Admit Cards, Venue and Time of the Entrance Test will be issued separately in due course of time. The Entrance Test will be held on **10<sup>th</sup> May (Sunday), 2020.**

**Note:** The online submitted form is purely provisional and is liable to be cancelled at any stage subject to the final verification of the documents and even at any stage where such a document is proved to be fake/false.
