

**THE CANDIDATES ARE REQUIRED TO SUBMIT THE FOLLOWING ORIGINAL CERTIFICATES ALONG WITH SELF ATTESTED PHOTO COPY OF THE FOLLOWING DOCUMENTS AT THE TIME OF VERIFICATION:-**

1. Hard copy of online application form **mentioning Roll No. at the Top Right-Hand corner**. Application Forms are available in the website of the Commission. The candidates are required to download the same using their respective username/mobile number/e-mail and password /OTP etc through **Admin Login Section** of the OPSC website.
2. **Three (03) passport size photographs tagged** with the Application Form and **One (01)** pasted at **space provided in the CIF (Candidate Information Form)**.
3. **H.S.C. or Equivalent Certificate** in support of declaration of age.
4. **Bachelor's Degree Certificate in Law and Law Degree Marksheets** from any recognized University in India.
5. Certificate showing adequate knowledge in Computer Application.
6. Required **Odia Test Pass Certificate** issued within **31.12.2021**.
7. **In-service Certificate** from the Competent Authority mentioning continuation in Government Service in case of in-service candidate availing age relaxation.
8. **Caste Certificate by birth** in Support of claim as SCs/ STs/S.E.B.Cs (Please see and refer Note- 1 of the Advertisement) issued within
9. **Recent SEBC Certificate** (issued within **01.01.2019 to 31.12.2021**), wherever applicable.
10. **Permanent Disability Certificate** indicating percentage of disability (i.e., **40% and more**).
11. **Discharge Certificates** in case of Ex-Serviceman issued by the Commanding Officer of the Unit last served. Ex-Serviceman candidates must submit an affidavit undertaking that he has not been appointed against any civil post after retirement from military service.
12. **No Objection Certificate** issued by the Competent Authority in case of in-service candidates; wherever applicable.
13. **Any proof of photo Identity**.
14. **Attestation Form** duly filled-in by the candidate and signed by a Gazetted Officer (to be downloaded from the website of the Commission).
15. The candidates are required to mention **"Submitted by me"** and put their **full signature and date of verification on each Xerox copy** of documents.
16. **Bio-data form (CIF)** (to be downloaded and duly filled in with passport size photograph affixed).
